

Terms and Conditions of the "FoneYam My Story Competition" Competition

- 1. The name of the competition is **"FoneYam My Story Competition"** (the Competition").
- 2. The promoter of the Competition is Tenacity Financial Services, a division of Pepkor Trading (Pty) Ltd ("the Promoter").
- 3. The Competition will run from **Monday, 26 May 2025 to Thursday, 29 May 2025** (both days included) ("the Competition Period").
- 4. To be eligible to enter the Competition a person must -
 - 4.1. be an active customer of FoneYam; and
 - 4.2. during the Competition Period, receive an invitation via WhatsApp from the Promoter to share their story of how their FoneYam Smartphone rental added value to their life.
- 5. A person who is eligible to enter the Competition must share their story by replying to the WhatsApp as provided for in 4.2 above, with a video or voice note of at least 30 (thirty) seconds ("Customer WhatsApp Story").
- 6. A person who successfully submits their Customer WhatsApp Story by no later than **Thursday, 29 May 2025 at 23:59** will become a participant in the Competition. ("Participants")
- 7. If a Customer WhatsApp Story is not submitted, or is unclear or incoherent, or is less than 30 (thirty) seconds, or describes anything that contravenes any South African laws (directly / indirectly), or in any form promotes discrimination or profanity (directly / or indirectly), or infringe on the rights of any person(s) (directly / indirectly), the Customer WhatsApp Story will be disregarded in the winner selection and such Participant shall be excluded from winning in the Competition.
- 8. Participants stand a chance to win 1 (One) of 10 (Ten) Ackermans Vouchers to the value of R 200 (Two Hundred Rand) each.
- 9. Entry is free but standard SMS and data rates apply. Participants may only enter the Competition once and may only win one prize in the Competition.

- 12. Any potential winner not excluded as provided for in clause 11 shall become a winner.
- 13. The Promoter will notify all winners that they have won by the latest on **Friday, 13 June 2025** via SMS. The notification SMS together with their electronic Ackermans Voucher shall be sent to the cell phone number on record with the Promoter.

- 14. The Ackermans Voucher must be utilised in accordance with Ackermans's rules regarding the use and expiry of vouchers ("Voucher Rules"). The Promoter shall not be liable to winners if the Ackermans Voucher is not used in accordance with the Voucher Rules.
